CRITIQUE OF LEAFLETS ISSUED IN CHRISTCHURCH: REPRESENTATION TO SECRETARY OF STATE FOR COMMUNITIES AND LOCAL GOVERNMENT, RT. HON. SAJID JAVID, MP

Prior to and during the Christchurch Borough local poll, several leaflets were circulated to households and made available in public places in Christchurch containing multiple inaccuracies. These were designed to stimulate participation in the local poll and, specifically, to encourage participants to respond 'no' to the question posed.

The persistent claim and overarching theme within all these leaflets is that Christchurch will be "ruled from / taken over by Bournemouth". This table captures a selection of inaccurate claims that were widely circulated, and sets out the factual position as is consistent with the Future Dorset proposal.

LEAFLET 1:

Content within leaflet circulated in May 2017. This included the Christchurch Borough Council logo and the Bournemouth Borough Council logo and was clearly designed to mislead readers to believe that it was jointly issued by these two local authorities, when in fact it was funded and produced by an individual based in Hampshire.

The True Facts of the Matter

Debt - Make no mistake about it, Bournemouth and Poole Councils are in **serious financial difficulty** and Bournemouth in particular, has a fifty year record of incompetent financial management, Members' conflicts of interest, allegations of dishonesty and concealment and secrecy in its dealings with its electorate.

If amalgamation were to take place Christchurch's assets would all be transferred to Bournemouth and used to help reduce Bournemouth's current debt burden.

Why would anyone in their right mind promote the idea that Christchurch should place itself under the total control of another Council which has such a long and appalling public service record?

Christchurch is debt free and by prudent financial management has £47 MILLION in assets.

Land - Bournemouth has almost NO building land left, in fact it has now commenced building all over its air parcel Christchurch or the other hand has a lot of Green Belt land which Bournemouth would own and control. Bournemouth would also control all planning matters.

Housing - Christchurch has a Waiting List of 600, Bournemouth and Poole have a Waiting List of 6,300. So we don't need to tell you why Bournemouth and Poole are interested in taking over our Green Belt and our land!

We wouldn't be able to control development on our Green Belt. We couldn't protect our sea front or Overcliff. We couldn't control the green spaces in the Town. We couldn't keep Christchurch homes for Christchurch people and we could find that we are forced to maintain a 'Gypsy and Traveller Site' for all three towns.

The Airport - the government has plans to allow business rates to be retained by local authorities. Bournemouth Airport is of course in Christchurch. It is a major employer and generates a considerable amount of money which would all go to Bournemouth.

Rates - Christchurch ratepayers pay more than ratepayers in Bournemouth and Poole and the Consultants, PwC, estimate that Christchurch ratepayers would continue to pay higher rates for the next 20 years with the 'surplus' going directly towards Bournemouth's debts.

So how does Christchurch benefit from this Proposed Amalgamation?

The simple answer is that it doesn't! It strips Christchurch of its thousand years of Sovereignty and its Mayoralty, its Royal Charter, its assets and its control over the management of its own affairs.

Statements and Facts

But first, a word about the Consultants PwC who handled the 'Amalgamation Consultation'

PwC are one of the UK's four main accounting firms but they do not enjoy a good reputation. An investigation into their activities in Luxembourg by the House of Commons Public Accounts Committee in 2015 stated that PwC promoted tax avoidance schemes 'on an industrial scale' enabling private and corporate clients to avoid millions of pounds of taxes which should have gone to the Exchequer.

They are also currently in a dispute with the Regulator over auditing failures in respect of the collapsed social housing group Connaught and are attempting to avoid a fine of £6million. Just the type of organisation most sensible people would think twice about employing!

The Reports they produced to support the proposed amalgamation are totally flawed and elements of them veer on the edge of dishonesty. They failed to produce a Business Plan, basically because it would not have stood up to any form of scrutiny and simply described how reducing staff numbers in the nine Councils would lead to savings of 'between £28 and £65 million a year'. Take those figures to your Bank Manager and he would show you the door!

And now a few gems from PwC:

PwC: 'All services would be delivered by one Council rather than two which would make it more accountable to residents.'

How can one 'Super Council' covering 400,000 people be held more accountable by just 40 elected Councillors when there are currently 150 looking after their residents' interests? Christchurch would be lucky to have a maximum of two Councillors in the Cabinet of any new 'Super Council'!

PwC: 'A single Council would be more efficient and better able to maintain services across the conurbation'. Large Councils lose touch with their electorate, react too slowly, 'navel gaze' and become inefficient. Government research into Council management has shown this to be the case. Big is NOT beautiful.

PwC: 'One Council could better plan strategic services such as roads and traffic, coastal protection and economic development.'

A new Authority, with equal representation from all Councils is already being set up to plan these services. You DON'T need to give up control of your own Town to cooperate with others!

PwC: 'A larger Council would be more resilient in dealing with the challenges ... by maintaining larger service teams.'

A complete nonsense: Christchurch has demonstrated through its years of partnership with East Dorset District Council that it is able to have one Officer Teams successfully managing two Sovereign Councils.

Some Facts You Should Know

There are a number of issues associated with any merger between Christchurch, Bournemouth and Poole and these issues will affect you directly.

The Financial Situation

Bournemouth and Poole are **heavily in debt** but Christchurch is **debt free**.

Householders in Christchurch pay an average of £200.00 more in Council Tax than those in Bournemouth and Poole.

If a merger takes place this £200.00 'recess' from every Christchurch Council tax payer will be **set against the debts of Bournemouth and Poole**. This could go on for at least ten years until tax rates are harmonised. How do you feel about subsidising council tax payers in Bournemouth and Poole for the next ten years?

Prudent financial management by Christchurch Council has resulted in the Borough having £60,000,000 in assets and nearly £12,000,000 in cash.

These assets and cash reserves would all be given to Bournemouth.

Land

Bournemouth has almost no land left for housing and is not going to be able to meet the Government's house building targets. They have also started building on their car parks. However, Christchurch has no shortage of Green Belt land all of which would be transferred to Bournemouth.

Bournemouth Airport and the Airport Business estate produce considerable business rates for Christchurch. The land and income would all be given to Bournemouth.

Planning. All planning decisions relating to Christchurch would be taken by the new Council in Bournemouth. The new Council would have 80 Councillors of which between five and eight would represent Christchurch.

Those representing Christchurch would be in a **minority** and would be **easily outvoted** on all matters relating to Planning for any new developments in Christchurch. This places our Green Belt and other land, our **sea** front and coastal areas at risk of development.

The Licensing of Nightclubs, bars and restaurants would also be administered by Bournemouth, not a happy prospect if you see how badly Bournemouth Council has managed the 'Club Scene' in its own Town Centre. Drunks, fights and very bad behaviour are normal at the weekends.

And what are the benefits for Christchurch if they amalgamate with Bournemouth?

It's very sad that some supporters of 'Future Dorset' are frightening voters by saying that Christchurch can't afford to pay for social services if we refuse a merger.

Our MP Chris Chope has condemned these tactics, pointing out that Christchurch Council does not provide schools or social care.

Whatever happens services will still be provided by the top-tier Authority for the area, whether that is a Unitary Council or a County Council. **AND MEDICAL SERVICES WILL BE UNAFFECTED BY ANY CHANGE.**

The Council Tax Freeze that isn't.

One of the strongest supporters of Future Dorset has said that if a merger takes place Christchurch's Council Tax will be frozen. He really has found, then, the magic money tree.

The net "savings" relied on by Future Dorset were based on a 20-year period when Christchurch Council tax payers would pay more than in Poole and Bournemouth; and a 4% annual Council tax rise.

Chris Chope MP has been told that there is a maximum **FIVE YEARS** transition period. And the tax increase without a public vote is 2%. **This budget shortfall is enough to wipe out most, if not all, of the alleged savings.** So where will the money come from to finance this "truce"?

What's going on?

Last March 6 of the 9 Dorset Councils (including Bournemouth, Poole and the County Council) asked the Government to replace all the existing Councils with two new huge "Super-Councils." Christchurch would be swallowed up by a new Council covering Bournemouth, Poole and Christchurch, and the Council would inevitably be dominated by Councillors elected by Bournemouth. The plan is called "Future Dorset."

Why do Bournemouth and Poole want to take us over?

Bournemouth and Poole Councils both really need to raise their Council Tax enough in recent years. They are both heavily in debt while Christchurch is debt-free. Both are short of building land for the Government's required new homes programme. Bournemouth especially has run out of land (i.e. where and what type of new homes are built) leaving us with no choice but to build on the Green Belt. Christchurch has cash reserves, has plenty of open space and has the Airport.

Isn't it a done deal?

By no means. Our MP Chris Chope has persuaded the Government to let us submit alternatives. We can show our consent by showing that the people of Christchurch do not want rule from Bournemouth. There are also other alternatives - but basically the Council doesn't want change.

But surely Christchurch will continue to exist?

Yes, there will still be a place called "Christchurch". But people living there will no longer be able to decide on how that place is shaped. We will lose control over Planning, allocation of land (i.e. where and what type of new homes are built) leaving us with no choice but to build on the Green Belt. Christchurch has cash reserves, has plenty of open space and has the Airport.

Surely we'll have Councillors on the new Council. Won't they be able to protect us?

Their legal duty will be primarily to the new Council. In any event, the law says that Councillors are allocated in line with population. If there were 80 Councillors, Christchurch would have no more than 9. Bournemouth would have 71.

What exactly, then, would Christchurch get out of this?

Good question. Some Christchurch Councillors have been asking this for the whole period of this plan. And no-one, no one at all, has ever bothered to try to give an answer. Christchurch has provided high quality and efficient services to its residents and has kept Christchurch a place where "Time is Precious". **Will the new Council be able to do this?**

CHRISTCHURCH REFERENDUM -VOTE **NO**

- The proposal is for Christchurch Council to be abolished and joined as one large Council with Bournemouth and Poole Councils. This new Council would have a NEW NAME.
- Christchurch has 24 Councillors, of which, the majority of them have voted against Christchurch joining a Unitary Authority with Bournemouth and Poole.
- Christchurch has 5 Dorset County councillors, and all of them have voted against Christchurch joining a Unitary Authority with Bournemouth and Poole.
- Therefore Christchurch is represented within Dorset by 29 Councillor positions covering all services

A Unitary Authority would join together Christchurch, Bournemouth and Poole as one "City by the Sea", a brand new Statutory Authority .

Current populations:	Bournemouth 195,000	Poole 150,000	Christchurch 50,000
Current No. of Cllrs.:	Bournemouth 54	Poole 42	Christchurch 29

- There will be a reduction of Councillors in the New Council - but with increased allowances.
- No. of Cllrs. in New Unitary Authority, covering all services, calculated by proportion of population:
Bournemouth 38 Poole 29 Christchurch 9
- Therefore Christchurch would have very poor representation in the new Unitary Authority

SERVICES DEALT WITH BY CHRISTCHURCH'S 24 COUNCILLORS – WHERE IT HAS CONTROL

- Local Planning and Licencing - deciding what is in keeping with the Borough and if new licenced premises (alcohol, music, or dancing) are appropriate
- A Local Plan for Christchurch sets out policies on certain issues:
 - Allocation of future Land Supply for Housing
 - Location and amount of New Housing Development (Roeshot Hill for instance);
 - Setting out Transport needs
 - Future Employment Areas including Bournemouth Airport and Business Park
 - Green Belt and Environment

CHRISTCHURCH WOULD LOSE CONTROL OF ALL OF THESE FUNCTIONS THEY WOULD BE TRANSFERRED TO THE NEW UNITARY AUTHORITY

WHERE CHRISTCHURCH WOULD HAVE APPROXIMATELY 9 COUNCILLORS OUT OF 76 THERE WOULD BE A COMPLETE LOSS OF LOCAL CONTROL

This means that Cllrs. from outside of Christchurch could dictate the location and amount of new housing development, the future of the green belt, whether to grant or refuse any planning application in Christchurch, and the location of licenced premises. It is worth noting that Bournemouth has very little land to accommodate new housing required by Government, so they would have to look to Christchurch and Poole for land.

SERVICES DEALT WITH BY DORSET COUNTY COUNCIL where Christchurch has 5 Councillors

- The County Council deals with Adult Services; Children's Services; Highway and Rights of Way Issues; Strategic Minerals and Waste Planning. Part of the Council Tax goes towards paying for these, and these services would be transferred to whichever new Authority Christchurch joins.
- Whatever happens, these services will continue to be provided by a top-tier Authority. Some may tell you they are at risk. They are not.

ALTERNATIVES

- Christchurch Council voted against joining with Bournemouth and Poole. Christchurch was previously part of Hampshire. The Council is having discussions with them to see if it could rejoin Hampshire County, thus Christchurch would retain its independent status, local control, and continue to provide all local services. Hampshire County Council would provide the strategic services, just as Dorset County Council does at the moment. There are other options too.

COUNCIL TAX

- Christchurch Council Tax is higher than that of Bournemouth or Poole. In a new Unitary Authority, Council Tax should be equal. The proposal put to the Secretary of State was based on taking 20 years to harmonise the three Council Taxes and modelled on annual increases. Recently the 20 years has been drastically reduced to what might be 2 or 3 years. A Special Group is investigating what to do about this, and will report back on 15th December. It has been stated that Christchurch Council Tax could be frozen or reduced while the other two catch up. This scenario was not modelled into the figures put to the Secretary of State, therefore it follows that there would be much reduced Council Tax income and a new Unitary Authority would fail to make the savings previously set out in last year's consultation.
- THE FIGURES NO LONGER ADD UP AND NO-ONE SEEMS TO BE MAKING THAT CLEAR**
- It appears that this is a short term offer of frozen Council Tax to induce Christchurch residents to join Bournemouth and Poole.
- Hampshire Council Tax is lower than Dorset's, so if we joined Hampshire, it is unlikely that Christchurch Council Tax would increase and may even decrease.

SAVINGS?

- We are told that this is all about saving money, and in the current financial climate savings will have to be made. The Government has reduced its grants to Councils. Christchurch has been prudent and is financially sound even with a grant reduction. Christchurch has a very good reputation and is a good partner for any other Council. Up to April 2019 Christchurch has no funding gap at all. Other Councils have not been so prudent, some have blatantly wasted money (e.g. surf reef, Imax and a failed bank), others have not increased their Council Tax in past years and now find themselves in debt.
- The proposal which the Secretary of State has before him includes financial calculations which went out with the public consultation in the Summer of 2016. We are now around 16 months on from then, and much has changed financially, they are out of date, and inaccurate.

CONCLUSION

- CHRISTCHURCH COUNCIL IS CURRENTLY BEING FORCED INTO A SINGLE COUNCIL WITH BOURNEMOUTH AND POOLE, WHICH IT VOTED AGAINST JOINING.
- CHRISTCHURCH IS INVESTIGATING OTHER ALTERNATIVES, ONE OF WHICH IS REJOINING HAMPSHIRE.
- THE SECRETARY OF STATE, HAS GIVEN US AN OPPORTUNITY, BEFORE MAKING HIS FINAL DECISION, TO FIND OUT IF THERE IS "LOCAL CONSENT", HENCE THIS REFERENDUM
- LOOK AT THE BIG PICTURE - DO YOU WANT TO BE PART OF A NEW "CITY BY THE SEA" WITH BOURNEMOUTH AND POOLE, WHICH WILL DEAL WITH ALL LOCAL ISSUES, WITH A MINORITY AMOUNT OF COUNCILLORS TO REPRESENT YOU?
